Takatsuki City Secondary Human **Rights Policy Promotion Plan** (Summary)



Objective of developing the plan

As a successor plan to the "Takatsuki City Human Rights Policy Promotion Plan (the preceding plan formulated in March 2015), this plan aims to reflect changes in social perception of human rights which have taken place during the period of the preceding plan.

Basic idea of the plan

This is a plan on human rights aimed to realize "a town that is lively and where residents' lives are satisfying" as the future urban vision, which is stated in the basic concept of "The 6th Takatsuki City Comprehensive Plan" and aims to develop an effective human rights policy in coordination with related administrative plans.




The plan will last for 9 years from FY2022 to FY2030, provided, however, that, if will be revised as needed in accordance with changes in social conditions and changes in circumstances on human rights.

► The 7th Takatsuki City Human Rights

- Awareness Survey (conducted in FY2019) * Although there is no major change compared to the preceding 6th survey, improvement is observed in many items.
- * A correlation was observed between the degree of understanding of civil rights in the Constitution and awareness of human rights issues.
- * A tendency that people in their 10s and 30s affirm the selfaccountability of socially vulnerable people was observed.

Regarding human rights violations related to the COVID-19 (survey)

(conducted in FY2020)

- * Main consultations
 - · Child abuse and domestic violence associated with an increased time spent at home
 - Human rights violations against infected people and close contact persons
 - Human rights violations against medical staff and their families, etc.
 * Extracted problems with a larger number of consultations from the total number of consultations (140) obtained from surveys to municipalities in Osaka, Takatsuki city and other organizations.

Problems in different fields

*It is necessary to view human rights issues as our own problem, not as a discriminatory problem in a narrow term, and take constant actions.


Human rights of women	Human rights violations such as violence, gender equality in a wide range of fields, etc.
Human rights of children	Child abuse and bullying, internet damage, recognition as rights holders, etc.
Human rights of the elderly	Environment where they can live a lively life, protection of human rights, efforts to protect against infectious diseases, etc.
Human rights of people with disabilities	Lack of understanding, discrimination, restrictions on activities, barriers that restrict social participation, etc.
Buraku Discrimination (DOWA issue)	Legal efforts, internet damage, understanding for solution
Human rights of foreign citizens	
Other human rights issues	Ainu people, HIV-infected people (HIV, leprosy, hepatitis, COVID-19), people released from prison after serving sentences, crime victims, etc., internet human rights violations, victims abducted by North Korea, people without home, sexual orientation/gender identity (sexual minorities), human trafficking (forcing sexual services and labor, etc.), human rights issues arising from the Great East Japan Earthquake, worknige, and human rights (harassmert etc.)



- Provide education and enlightenment on "correct understanding of human rights".
- All people can view human rights issues as our own problem and take actions.
